By using our Sites, you consent to our use of cookies, pixel tags and other means of identification and local storage (together referred to as “Cookies”) in accordance with this Rubax Lifts Ltd cookie policy (“Cookie Policy”). **If you do not agree to our use of Cookies and other means of identification in this way, you should set your browser settings accordingly or not use our Sites.**

## 2. What are Cookies?

### What is a Cookie?

A Cookie is a small piece of data that is placed on your computer or mobile device by websites you visit. Cookies are widely used in order to make websites work, or work more efficiently, as well as to provide information to the owners of the website.

### What does a Cookie do?

A Cookie may store or retrieve information on your browser. This information might be about you, your preferences or your device and is mostly used to make the site work as you expect it to. A Cookie enables the website to remember your actions and preferences (such as login, language and other display preferences) over a period of time, so you don't have to keep re-entering them whenever you come back to the website or browse from one page to another.

The information does not usually directly identify you, but it can give you a more personalised web experience.

## 3. Purpose of this Cookie Policy

**This Cookie Policy explains why and how we use Cookies and other means of identification when you visit the Sites.**

At Rubax Lifts Ltd and at Schindler, we strive to honour your right to privacy. To this end, we have issued this Cookie Policy. It describes how, why and the types of Cookies and other means of identification we use when you (i) register or visit the Sites, [www.rubax.co.uk](http://www.rubax.co.uk) or associated Sites or (ii) engage with us to use the services that Rubax Lifts Ltd. provides on the Sites.

This Cookie Policy applies to the Sites and applications accessed or used through such Sites or platforms which are operated by or on behalf of Schindler.

## 4. Why we use Cookies

### Why we use Cookies

We use Cookies to distinguish you from other users of our website and of websites of our network, to let you navigate between pages efficiently and to store your preferences. Cookies provide you with a good experience when you browse on our Sites and they help us tailor our Sites and services to your personal needs. They also allow us to gain customer satisfaction feedback and to communicate to you elsewhere on the internet.

If you revisit our Sites, we may recognise you, even if we do not know your identity.

### Cookies set by Rubax Lifts Ltd and by Schindler or third parties

In many cases, these Cookies lead to the use of your device’s processing or storage capabilities. Some of these Cookies are set by Rubax Lifts Ltd or Schindler itself, others by third parties; some only last as long as your browser session, while others can stay active on your device for a longer period of time.

## 5. How to manage your Cookie settings on your browser

Internet browsers allow you to change your Cookie settings, for instance to block certain kinds of Cookies or files. You can therefore block Cookies by activating the setting on your browser that allows you to refuse the setting of all or some Cookies.

However, if you use your browser settings to block all Cookies, you may not be able to access all or parts of our Sites, due to the fact that some may be functionality Cookies.

## 6. The types of Cookies we use

We may use the following types of Cookies

- **Functionality Cookies** are necessary for functionality or services that you request or for the transmission of communications on our Sites.
- **Analytical Cookies** are used to carry out performance and audience metrics regarding our Sites.
- **Other Cookies** are used for tracking across a network of other websites, advertising, etc.



<b>Functionality Cookies</b>	<p>Functionality Cookies are necessary for functionality or services that you request or for the transmission of communications on our Sites. They cannot be switched off in our systems. Functionality Cookies are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these Cookies, but some parts of our Sites will then not work as a consequence.</p> <p>Functionality Cookies do not store any personally identifiable information.</p> <p>Functionality Cookies do not require your consent.</p>
<b>Analytical Cookies</b>	<p>Analytical Cookies are used to carry out performance and audience metrics regarding our Sites. These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our Sites. They help us to know which pages are the most and least popular and see how visitors move around the Sites. All information these Cookies collect is aggregated and therefore anonymous.</p> <p>For Analytical Cookies we request your consent before placing them on your computer or mobile device. You can give your consent by continuing to use our website,</p> <p>If you do not allow these Cookies we will not know when you have visited our Sites, and will not be able to monitor its performance.</p>
<b>Other Cookies</b>	<p>Other Cookies are used for tracking across a network of other websites, advertising, etc.</p> <p>For Other Cookies we request your consent before placing them on your computer or mobile device. You can give your consent by continuing to use our website, or by clicking on the appropriate button on the banner displayed to you.</p> <p>If you do not allow these Cookies we will not know when you have visited our Sites, and will not be able to monitor its performance.</p>

### Adobe Analytics

The Sites use the technologies of the web analytics tool Adobe Analytics (previously called Omniture SiteCatalyst) to collect non-identifiable and to aggregate information to improve the contents of our Sites or to compile, for internal and market research purposes, anonymous aggregated statistics about individuals using our Sites. Data of site visitors is anonymised and Rubax Lifts Ltd and Schindler cannot identify site visitors.

### Google Analytics

We may use Google Analytics on our Sites. These are services provided by Google Analytics Google LLC which is located in in the U.S., [www.google.com](http://www.google.com).
